I acknowledge that by signing this document, I am assuming risks, and agreeing to indemnify, not to sue, and release from liability the Village of Buckley, Buckley Community Group, and their respective agents, employees, volunteers, members, sponsors, employees, promoters and affiliates (collectively "releasees"), and that I am giving up substantial legal rights. This entry form and release is a contract with legal and binding consequences. I have read it carefully before signing, and I understand what it means and what I am agreeing to by signing. I hereby freely agree to and make the following contractual representation and agreements. I acknowledge that running is an inherently dangerous sport and fully realize the dangers of participating in a running race, whether as a runner, walker, or otherwise, and fully assume the risks associated with such participation including, but not limited to: the dangers of collision with dogs, their leashes, or unpredictable collisions with other pedestrians, vehicles, other racers, and fixed or moving objects; the dangers arising from surface hazards, including pot holes, inadequate safety equipment, the releasees and releasors own negligence, the negligence of others and weather conditions; and the possibility of serious physical and/or mental trauma or injury, or death associated with running/walking. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "successors"), I hereby waive, release, discharge, hold harmless, and promise to indemnify and not to sue the Village of Buckley, the Buckley Community Group and all volunteers, sponsors, organizers, and promoting organizations, property owners, law-enforcement agencies, public entities, special districts and properties that are in or any manner connected with this event, and their respective agents, officials, and employees through, or by which, the events will be held, from any and all rights and claims including claims arising from the releasees and releasors own negligence, which I have or which may hereafter accrue to me, and from the event. I agree it is my responsibility to be familiar with the race course, the rules, and any special regulations for the event and agree to comply with all such rules and regulations. I understand and agree that situations may arise during the run/walk/event of that which may be beyond the control of the releasees, and I must participate so as to neither endanger myself nor others. I accept responsibility for my condition and adequacy of training in connection with this event. I have no physical or medical condition which would endanger myself or others if I participate in this event, or would interfere with my ability to safely participate in this event. I hereby grant full permission to use my name and likeness, as well as any photographs and any record of this event in which I may appear for any legitimate purpose, including advertising and promotion. I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I, or my successors, assert a claim contrary to what I have agreed to in this contract, the claiming party shall be liable for the expenses, including legal fees, incurred by the releasees defending the claims. This contract may not be modified orally and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision here and/or as consent to any subsequent waiver or modification. I consent to the release by any third party to releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from the event. Every term and provision of this contract is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
